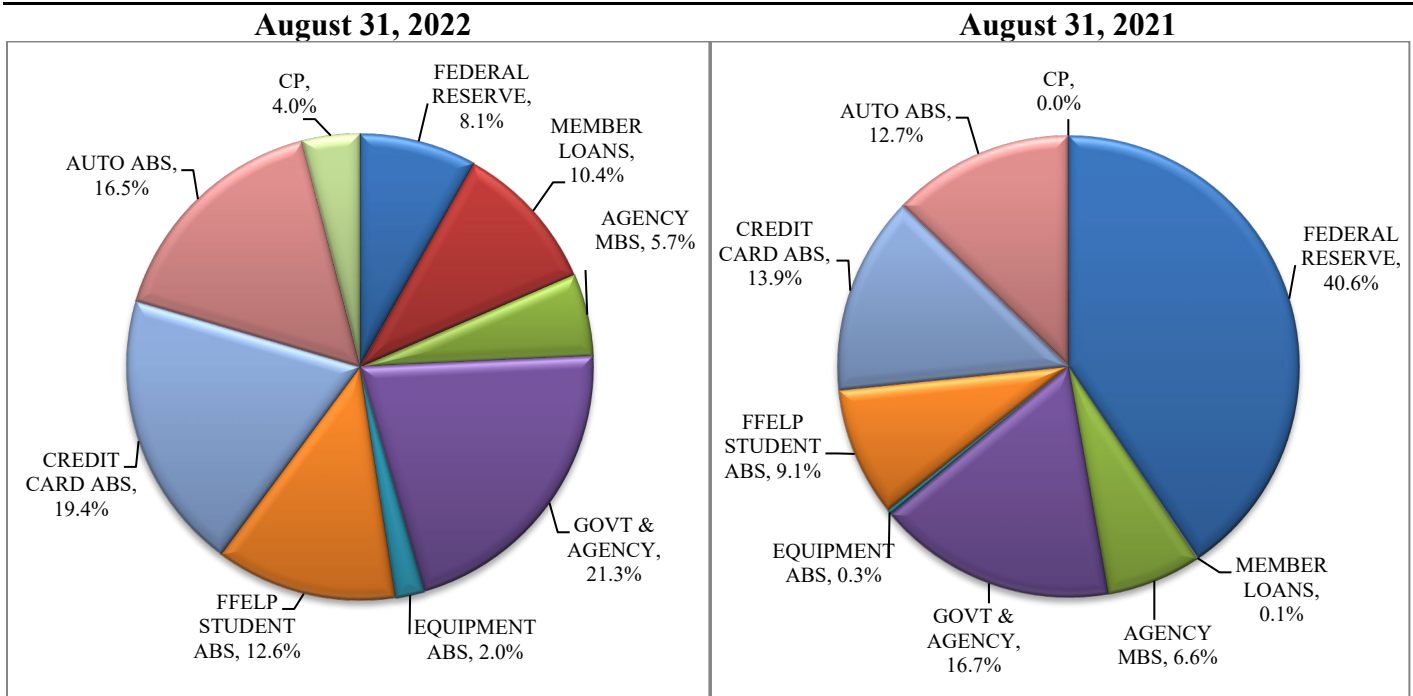

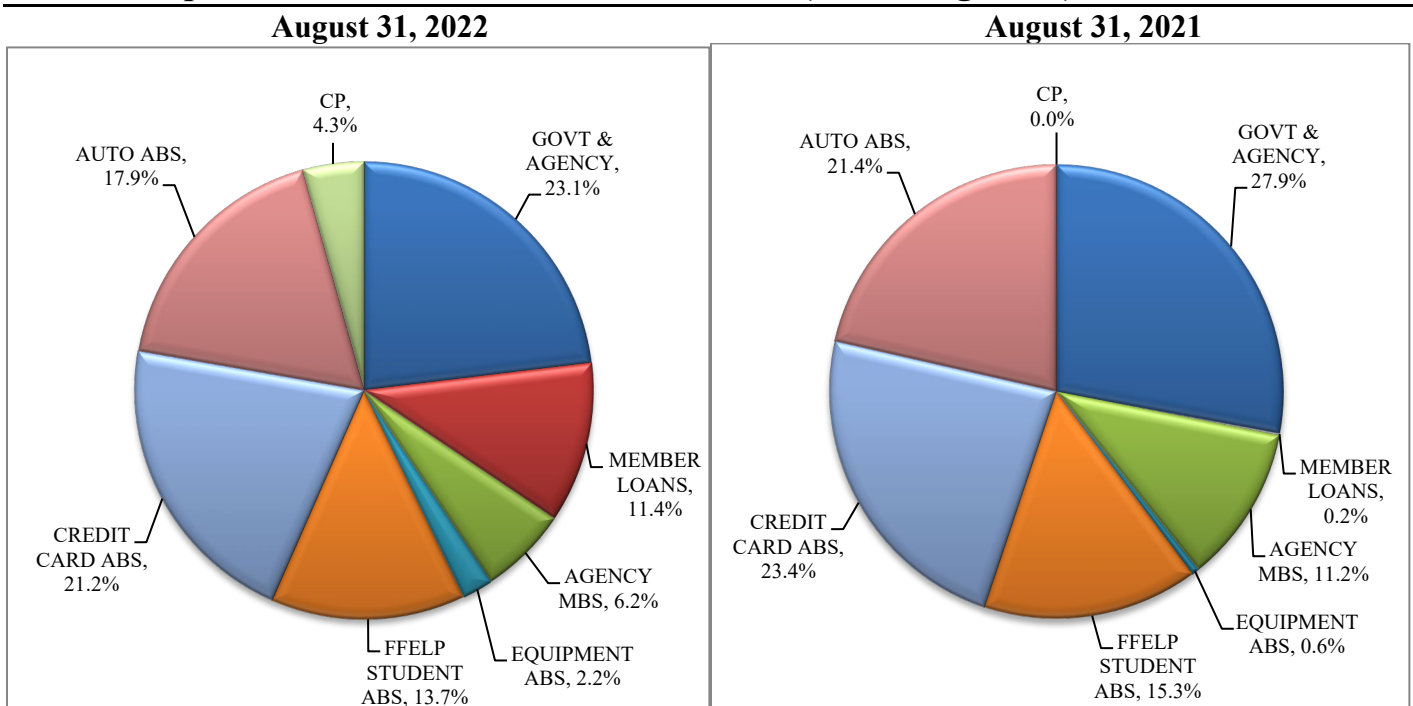
Diversification

As of August 31, 2022, Corporate Central had 8.1% of the investment and loan portfolio in deposits at the Federal Reserve. Investments in credit card asset-backed securities (ABS) represented 19.4%, FFELP student loan ABS, which are comprised of student loan-backed securities that are at least 97.0% guaranteed by the Department of Education, accounted for 12.6%, auto loan/lease ABS represented 16.5%, and equipment ABS represented 2.0% of the portfolio. Commercial Paper (CP) represented 4.0%, agency mortgage-backed securities, including agency commercial mortgage-backed securities (MBS) represented 5.7%, government & agency debentures represented 21.3%, member loans comprised 10.4%, and Home Equity ABS accounted for less than 0.01% of the total portfolio.

The risk rating breakdown and unrealized loss of (\$53,336,751) on our investment portfolio can be seen below. Corporate Central classifies all marketable securities holdings as Available-For-Sale (AFS), which means all investments are marked-to-market monthly. Earlier this year, market yields soared higher at the fastest pace in nearly 40-years as expectations of the extent and timing of potential Fed hikes increased. This resulted in a decline in market values and an increase in unrealized losses over the last several months.

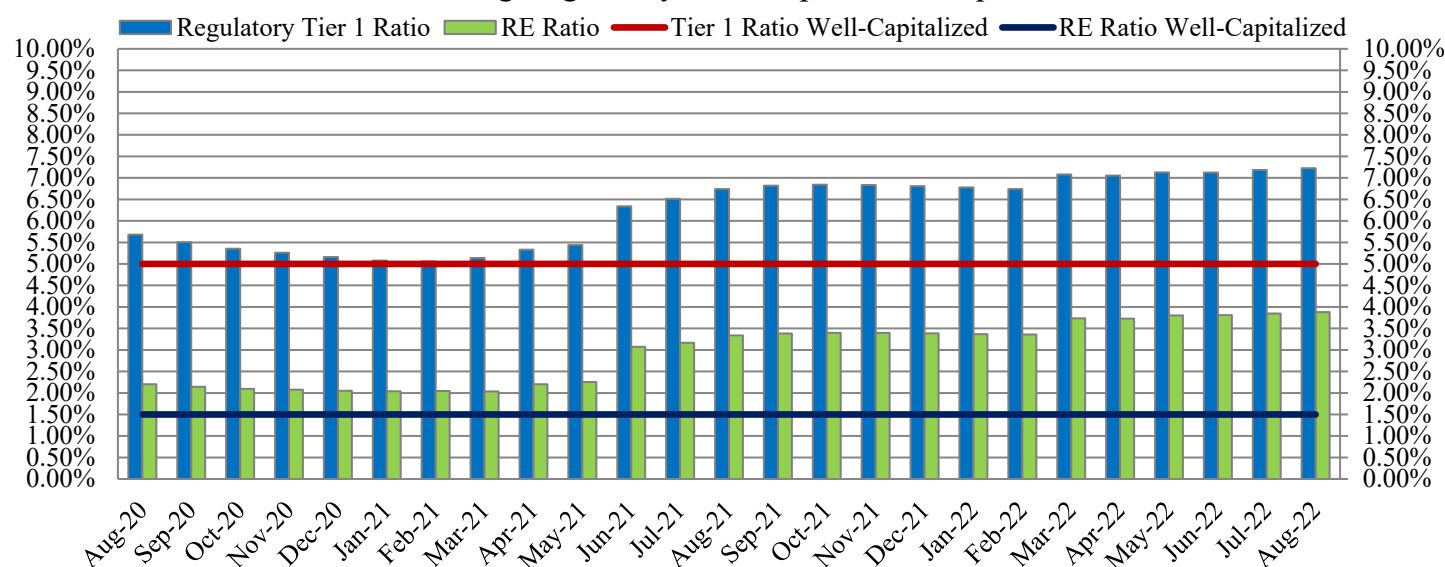

The graph below includes the Tier-1 Capital Ratios and RE Ratios and the regulatory well-capitalized requirements for each measurement.

Beginning in 2020, Corporate Central launched a multidimensional strategy to support our capital ratios during the period of unprecedented deposit and asset growth driven by the pandemic. The strategy has resulted in a total increase in Tier 1 capital of \$89.1 million, or 53.8%, since the beginning of 2020 in addition to redirecting approximately \$5 billion in deposits into off-balance sheet products over that same timeframe, which allowed Corporate Central to remain well-capitalized throughout this extraordinary period. Substantial deposit levels due to the pandemic continue to be a challenge. Corporate Central will continue to work hard to ensure that it is solidly positioned in relation to requirements.

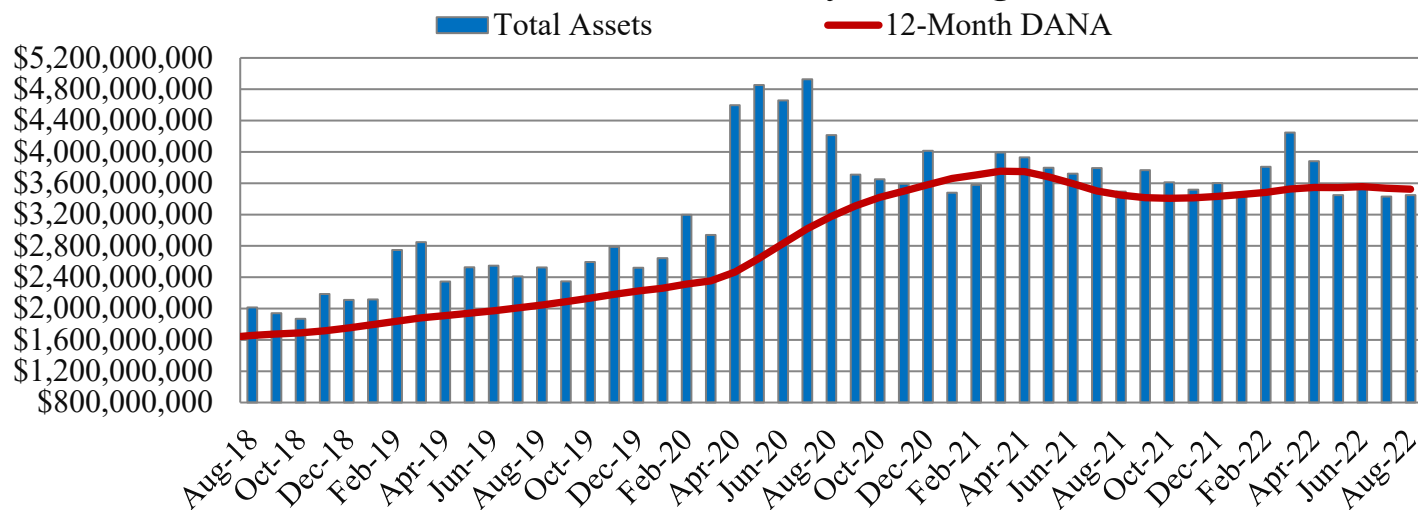
Tier 1 Capital & Retained Earnings Ratios

In addition to growth in retained earnings and PCC, much of the change in the Tier 1 Capital Ratio over the previous few years can be attributed to changes in Corporate Central's 12-month DANA, which is the denominator in the capital ratio calculations. These changes, as can be seen below, have mainly been the result of membership growth and the changing liquidity cycle driven by the pandemic and economic environment, which has impacted our members' liquidity levels. Corporate Central had extraordinary asset growth as member deposits surged due to significant government stimulus payments and a substantial drop in consumer borrowing and spending due to the pandemic, and deposits have been trending lower in recent months but remain abnormally high. As mentioned earlier, Corporate Central redirected approximately \$5 billion in deposits into off-balance sheet products, allowing for a very significant reduction in our assets and 12-Month DANA.

Corporate Central's interest rate risk levels and economic value of capital as measured by Net Economic Value (NEV) and NEV Ratio remain well within regulatory limits as can be seen below.

*NEV is the fair value (FV) of assets in each scenario minus the FV of liabilities in that scenario and is considered the economic value of capital. Perpetual Contributed Capital (PCC) and Non-perpetual Capital (NCA) are considered capital in the NEV calculation.

Additionally, Corporate Central's liquidity position remains strong. The majority of available liquidity is in the form of cash and marketable securities. However, Corporate Central has external lines of credit that can be used as required.
